I. CONVENE MEETING

2024 and 2025 Focus Topics Planning
 Diane Taniquchi-Dennis, Chief Executive Officer

Reviewed the focus topics for 2025.

Taniguchi-Dennis provided overview of CWS focus topics for 2025 and actions taken in 2024.

Chair Harrington requested additional detail and updated formatting, including topic summaries.

Taniguchi-Dennis acknowledged feedback and CWS will make requested improvements.

2. 2025 Legislative Overview (13:22)

Tracy Rainey, CWS Government Relations Manager Pete Evich, from Van Scoyoc Associates Kristina Surfus, from the National Association of Clean Water Agencies (NACWA)

Rainey, Evich, and Surfus presented the 2025 Legislative Overview PowerPoint

Issues discussed

Director Willey applauded CWS for implementing the Essentials program for newly elected officials. Additional discussion on building relationships.

Rainey reviewed legislative priorities at the state level and bills CWS is monitoring. Discussion touched on water reuse, industrial symbiosis, water workforce, biosolids, PFAS, housing, and funding for the Oregon Department of Environmental Quality.

Evich provided an overview of the congressional makeup and recent federal actions and appointments.

Chair Harrington asked if Edwards and Rainey received the external communication weekly email that lists the Board's external meetings for the current and following week.

Discussion included new Executive Orders, local impacts of pausing or freezing federal funding, and Safety of Dams funding. Evich said CWS is monitoring budget reconciliation measures and annual appropriations.

Chair Harrington asked how CWS might be threatened by deregulation or dismantling the federal workforce and the relationship with the watershed permit and the Clean Water Act.

Surfus provided an overview on NACWA and its legislative priorities.

Chair Harrington asked if NACWA is reaching out to new members of congress. Surfus shared that NACWA sends introduction letters to new members and meets for further discussion.

Director Treece and Director Snider commented on the importance of receiving regular updates and insight about when outreach or advocacy would be useful.

Rainey provided an update on the Scoggins Dam project. CWS has frequent check-ins with the Bureau of Reclamation and Oregon's federal congressional delegation.

Director Snider asked which local partners have responsibility for water quality in the repayment analysis.

Taniguchi-Dennis described CWS's strategy to plan for Scoggins repayment. Payments will be due when construction is complete; CWS can negotiate a debt service agreement.

Chair Harrington said the CWS unappropriated fund balance is needed to accommodate the cost share for Scoggins Dam.

3. Board Compensation and Travel 2:55:05 Elizabeth Edwards, Chief of Staff

Elizabeth presented the **Board Compensation and Travel PowerPoint**

Issues discussed

CWS currently pays Washington County about 5% of salaries for Board members and key staff per an intergovernmental agreement to cover work done on behalf of CWS.

A salary commission sets salaries for Board members. The written reports don't reference CWS.

Several Board members suggested the salary commission could consider work related to CWS when setting salaries.

Board members discussed the percentage of time they devote to CWS work.

ORS 198.180 and 198.190 set a compensation cap of \$50 a day for members of special district governing boards.

Statute last updated in 1990s.

Edwards said CWS is planning to budget \$65,000 for directors' salaries for Fiscal Year 2025/26, pending outcome of Salary Commission.

CWS recommended one or two Board members travel to Washington D.C. for Water Week Policy Fly-In in April. Chair Harrington and Director Willey volunteered to represent CWS.

CWS recommended two or three Board members travel to Chicago for WEFTEC in the fall. Director Fai and Director Snider indicated interested.
